

PIERRE LACONTE was one of the three planners appointed in 1969 by the Catholic University of Louvain to produce the master plan of a new university town, near Brussels, and co-ordinate its implementation. Called Louvain-la-Neuve, it is now a thriving regional service centre, built along the university.

It includes an underground railway station and many energy, green and water-saving innovations such as a 200-ha forest public reserve, a dedicated rainwater reservoir treated as a lake. Its centre is entirely car-free. Its 2005 shopping mall, adjacent to the railway station, has 8 million visitors per year. The station is to double in size and to become part of the Brussels suburban railway network.

Abercrombie Award of the International Union of Architects 1982. Its 50th anniversary included international events such as participation to the Berlin exhibition about the sustainable city of the 20th Century¹.

Dr of Laws & Dr of Economics (Catholic University of Louvain); honorary Dr (Edinburgh Napier University). Part-time lecturer Department of Urban Studies and Planning, MIT (1980-85).

President, Foundation for the Urban Environment, Brussels² since 1999. Member (2004-11) and Vice-Chairman (2008-11), scientific committee of the European Environmental Agency³ for urban and spatial matters. its reports include "Urban Sprawl in Europe" (2007), "Quality of Life in Cities" (2009), and "European Eco-Forest System".

Honorary Secretary General of the International Association of Public Transport – UITP (Secretary General 1984-1999). UITP serves ca 100.000 members, both public and private, and has a staff of ca 120 in Brussels and regional offices in all continents⁴. its Millennium Database (2001/2006) compares mobility, land-use, and environment in 100 conurbations.

Member of the Lee Kuan Yew World City Prize Council for 2010 & 2012⁵, and member, advisory group for Singapore World Cities Summit 2012.

Member, evaluation team for the European Green Capital Award 2012 and 2013.

Member, Akademie der Künste, Berlin (Sektion Baukunst) from 1995 and Corresponding member, Deutsche Akademie für Städtebau und Landesplanung since 1999.

Past President, International Society of City, and regional Planners (ISOCARP). In this capacity he organised two world congresses in China (Dalian 2008 & Wuhan 2011⁶).
